

Rating Action: Moody's upgrades ratings of 12 Russian financial institutions; outlook stable

London, 12 February 2019 -- Moody's Investors Service ("Moody's") today upgraded where applicable the local and foreign currency long-term bank deposits, issuer and senior unsecured debt ratings of twelve financial institutions domiciled in Russia (see list of affected entities below). The rating action follows Moody's upgrade of Russia's sovereign debt rating to Baa3 from Ba1 on February 8, 2019.

The outlooks on the following entities' ratings have been changed to stable from positive/positive(m): Sberbank; Bank VTB, PJSC; VEB.RF; JSC DOM.RF; Gazprombank and Russian Agricultural Bank; while the outlook on the following banks remains stable: AO RAIFFEISENBANK; Alfa-Bank; DeltaCredit Bank; Eximbank of Russia; PJSC ROSBANK; Rusfinance Bank.

The agency's Macro Profile for Russia remains unchanged at Weak(+) and the banks' baseline credit assessments (BCAs) and adjusted BCAs were likewise unaffected.

RATINGS RATIONALE

DEBT, ISSUER AND LOCAL CURRENCY BANK DEPOSIT RATINGS

Moody's upgraded the senior unsecured and subordinated debts, issuer and local currency deposit ratings of six financial institutions where applicable; namely, Sberbank, Bank VTB PJSC, VEB.RF, JSC DOM.RF, Russian Agricultural Bank, and Gazprombank. The rating agency considers that these entities benefit from the enhanced creditworthiness of Russian government given their systemic importance, state ownership and role in discharging public policy, which makes government support for the affected liabilities very likely.

The outlooks on the respective debt, issuer and local currency deposit ratings were changed to stable, in line with the outlook on Russia's Baa3 government bond rating.

FOREIGN CURRENCY BANK DEPOSIT RATINGS

The increase in Moody's foreign currency deposit ceiling applicable to Russia to Baa3 from Ba2 led the agency to upgrade the long-term foreign-currency deposit ratings on ten financial institutions; namely Sberbank, Bank VTB PJSC, Russian Agricultural Bank, Gazprombank, Eximbank of Russia, Alfa-Bank, AO RAIFFEISENBANK, PJSC ROSBANK, DeltaCredit Bank, and Rusfinance Bank. These ratings were constrained by the previous foreign currency deposit ceiling of Ba2, but under the new foreign currency deposit ceiling of Baa3, fully incorporate support from their affiliates or from the Russian government.

The outlooks on the banks' respective long-term foreign currency deposit ratings remain stable, in line with the outlook on Russia's Baa3 government bond rating.

COUNTERPARTY RISK ASSESSMENTS AND COUNTERPARTY RISK RATINGS

The upgrade of Russia's sovereign rating to Baa3 from Ba1 as well as the increase in the country ceilings led Moody's to upgrade the long- and short-term counterparty risk assessments and counterparty risk ratings of six financial institutions where applicable; namely, Bank VTB PJSC, JSC DOM.RF, Gazprombank, Eximbank of Russia, Alfa-Bank, and AO RAIFFEISENBANK. These ratings and assessments include government support and benefit from the enhanced creditworthiness of the Russian government.

WHAT COULD MOVE RATINGS UP OR DOWN

For the majority of the affected financial institutions, their deposit, debt and issuer ratings are in line with or close to the Russian sovereign rating. Therefore positive rating action(s) on these financial institution ratings would be driven by a higher sovereign rating.

The agency could downgrade the affected entities' ratings if the Russian government's capacity or propensity to render support to financial institutions were to diminish.
